History of the Bayou Bounty Hunters

Part 1



This is an account of the genesis and continuing saga of the **Bayou Bounty Hunters Cowboy Action Shooting club**. To give a complete history of the club, I need to go back to the year 1996. Our origins started with the **Cajun Cowboys SASS** club located at the Baton Rouge Rifle and Pistol Club located in Zachery, La.

To the best of my knowledge, Cowboy Action competition in Louisiana started with the Cajun Cowboys. At the time, it was headed up by “**Mongo**” and “**Durango Dan**”. The matches were held on a monthly basis at the Baton Rouge Rifle and Pistol Club. Around 1997 Rattlesnake Blake was appointed as the club’s Territorial Governor and he represented the club in that capacity until 1999. Sometime in late 1997 the Baton Rouge Rifle and Pistol Club was shut down due to complaints from one of its neighbors (*an interesting story in its own right*). Interestingly enough, this action later prompted the La. Legislature to enact the **Range Protection Act** which helps protect existing ranges from being shut down due to complaints from neighbors who have encroached on the range after its being in approved operation.

The Cajun Cowboys at this point were without a range, and they were on the lookout for a new location in which to hold matches. A range, **Southeast Mississippi Gun Club**, was found in Mississippi just off of I-10 two miles from the La. border. Negotiations were held with the club, and the Cajun Cowboys were invited to use the range one day a month. Originally, the Cowboys were only allowed to set up matches on the twenty-five yard range. That being the case, members had to set up stages and change them for the next stage. At the end of the match, everything had to be broken down and stored in a container on the range. As I remember, we only shot three stages at that time due to the constraints of having to reset stages. Later on, we were allowed to use the one hundred yard range as well, and this facilitated speedier stage set-ups. Unfortunately, in early 1999, there was factional infighting within the Southeast Mississippi Gun Club relating to selling the club for profit to club members. The faction that supported the Cajun Cowboys lost in an election which resulted in the loss of range privileges for the Cowboys. Once again, the Cajun Cowboys were without a range to compete on.

Club members started looking for a new venue to be able to shoot Cowboy Action matches. During this time, a split occurred within the Cajun Cowboys wherein both groups were looking for a new range. Durango Dan and Mongo lead one group which retained the name Cajun Cowboys along with the club’s assets (targets and props). Rattlesnake Blake and several others moved in another direction.

It was at this juncture that a second Cowboy Action club in Louisiana came into existence. Rattlesnake Blake dubbed it the **Bayou Bounty Hunters**; however, it still did not have a place to shoot. It was during this time that **Dos Perros** suggested

that Rattlesnake and Soiled Dove come with him to look at a shooting range in western St. Tammany Parish, the **Tallow Creek Shooting Range**. The three traveled to the range which was basically a skeet, trap and sporting clays range. The range consisted of approximately two hundred acres of which a great deal was wet lands and woods. The shotgun venues took up the front half of the property. Rattlesnake engaged the owner, Mike, in negotiations to set up a Cowboy Action range on the property. A lease was finally agreed upon that gave the new cowboy club use of a back portion of the property adjacent to "duck pond" (*canned duck hunts*) which was no longer being used. **The Bayou Bounty Hunters finally had a new home in 1999 which was named "Coyote Creek."**

General Membership Meeting

December 14, 2013

Rattlesnake Blake called the meeting to order with the first discussion item being the upcoming Fisher House Charity Match 2014. Next he provided information from the TG Conference at the Summit regarding the distance of targets at local clubs and SASS's position on target distance.

The next discussion of the meeting regarded the past annual match. Members were encouraged to give their input on the good points of the match and those that need to be taken into consideration for future matches. Below is a list of the input received:

More efficient use of the long range shooting times. It was suggested that we use Thursday afternoon for long range shooting and cowboy skeet since the early morning hours of peering into the sun is not a popular time to get people on the line.

Putting long range on the clock with a time limit on shooting the long range targets as "chatting" time is taking up the time slot.

Holding side matches on the cowboy town in the morning and then having long range and cowboy skeet in the afternoon.

Wild Bunch side match could be reduced to 3 stages vs 4 stages

Shooting the main match stages 5/5 instead of 6/4 would provide more time for the Wild Bunch side match and also not be so tiring to shooting participating in both.

Banquet at the club house and caterers meals are both highlights of the weekend.

Discussion of pulling the four top shooters from their category standings.

Recognition of the state champions in the categories for a state championship.

Discussion of future buckle design - keeping design but changing to shiny buckle.

Big Daddy and Red River Rudy have offered to run an ATV side match which entails shooting from the ATV at balloons. This may be used as a fund raiser for charity match.
